Novotel Centrum Flanders

Please note that city tourist tax applies. It costs €1.50 per night; it is a local tax and needs to be paid directly to the hotel.

Coaching:

- Day 1 10 hours continuous service from airport to drop off at your hotel
- Day 2 10 hours continuous service from your accommodation
- Day 3 10 hours continuous service from your accommodation
- Day 4 10 hours continuous service from your hotel to drop off at the airport

DEPOSITS & TOUR PRICE

If you're happy with the quote, please let me know so we can get accommodation & coaching held for you.

Deposits are collected over the phone for your tour.

The required non-refundable deposit is €100pp. Once tour numbers are finalised and the flights secured, we can confirm the tour price advised on 19 March 2024.

CUT-OFF DATES

We recommend setting a date by which the passengers should have the deposit paid. If a passenger misses the book-on date, it may be necessary to charge a supplement if the flight price has increased.

PASSPORTS & VISAS

Irish passport holders do not require a visa for an Flanders & The Somme tour. However, passengers who will not be travelling on an EU passport may. It is the responsibility of the passenger to ensure that they have a valid passport or visa in time to travel with the group.

LUGGAGE INCLUSION, ADVANCED CHECK-IN & RESERVED SEATING

Some airlines have compulsory online check-in. We will use the passport information we collected via the online payment system in these cases.

We include the cost of seat allocation in the tour price that allows us to check-in the group in advance, where permitted.

YOUR ACCOMMODATION

Almost all destinations these days have a tourist tax. In most cases, we cannot include this in the tour price because it is payable locally. We've set out the current amount overleaf but it is subject to change.

Many hotels require a security deposit to be paid on check-in and returned on check-out upon inspection of rooms.

TOUR FINANCES

We can provide you with a report of who's booked on and who's paid what. This is real-time information which comes directly from our system. We recommend adding a contingency to the tour price. This can be rebated back to the Group Leader before your group travels. The final balance is due 10 weeks before departure.
